DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

The Greater San Diego Basset Hound Club is offering a maximum of 30 entries to be placed on a wait list to fill openings created by withdrawn entries. All entries, including wait listed entries, must be **received** by the Trial Secretary prior to the closing date. Entries withdrawn after closing will only be refunded when replaced by a wait listed entry. Checks will be shredded for any full entries that don't move off the wait list. CONDITIONS AND SEARCH AREAS

Search areas may be of any shape, and size specified in the Regulations for each class. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, asphalt, and on uneven surfaces. Trial will take place rain or shine. See regs for equipment that each HD handler needs to provide.

SITE INFORMATION

Staging Area will be out of view of search area(s). Staging area will include crating, warm-up and waiting area.

The Handler's Briefing will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there is an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during any group briefings. *The handler briefing may be modified due to current AKC guidelines*.

Warm-up area. The club shall designate a warm-up area. One labelled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. Clubs may also place blank containers.

Possession of Odors and Training. Chapter 5, Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectators are usually encouraged at scent work trials but may be limited or not allowed due to logistics. Spectating is at each judge's discretion.

Exhibitors and spectators are forbidden to discuss any details of the search with ANYONE.

Crating: You will be crating from your car, or you may set up canopies on the grass away from the church. There is no shade in the parking lot and limited shade on the grass. Please bring your own. GSDBHC will not be responsible for any lost or damaged items left at the show site. No overnight setups. There will be no overnight security.

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Greater San Diego Basset Hound Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Greater San Diego Basset Hound Club and reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Greater San Diego Basset Hound Club or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An offleash option may be offered at the discretion of the judge, only if the area is completely enclosed.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

It is NOT appropriate to scout or contact anyone at the trial location prior to the trial date. Many search locations are real-life environments, and such visits may risk the host losing the opportunity to use the location in the future.

Dogs may enter Novice B HD <u>and</u> Master HD – they must have earned the Novice, Advanced and Excellent HD Titles.
